**Sub: Release of Rs. 20.00 lakh (Rupees Twenty lakh only) as part payment of 1<sup>st</sup> instalment of Rs. 137.025 lakh of Central Share for preparation of Housing for All Plan of Action (HFAPoA) for 29 cities of Arunachal Pradesh - reg.**

Sir,

The undersigned is directed to convey the sanction of the President of India to the amount of **Rs. 20,00,000/- (Rupees Twenty lakh only)** as part payment of 1<sup>st</sup> instalment of Rs. 137.025 lakh of Central share to the State Government of Arunachal Pradesh for preparation of HFAPoA. A list of towns/cities for which part payment of first instalment is being released is at **Annexure-I**.

2. The above grant is subject to the following conditions:

- I. The above amount is part payment of first installment of grants approved as per the financial norms approved by 1<sup>st</sup> CSMC under HFA held on 17<sup>th</sup> September 2015.
- II. The above release is only for those cities which are approved by this Ministry under HFA mission.
- III. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- IV. States/cities to which assistance under RAY for preparation of SFPCoA have been given, should fully utilize that amount for preparation of HFAPoA, if the same city has been included under HFA.
- V. State Government of **Arunachal Pradesh** is required to furnish Utilisation Certificate as per GFR and Statement of Expenditure to the Government of India before claiming next instalment on utilisation of 70% of the amount released earlier for preparation of SFPCoA and the instant release for preparation of HFAPoA.
- VI. The amount of central assistance approved will form a part of capacity building plan of the State under PMAY-HFA (Urban) mission.

- VII. The Grant sanctioned will be utilized for the purpose for which it is released. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work and furnish physical and financial progress reports (every quarter).
- VIII. Where there is an element of cash transfer, the same may be made through PFMS/DBT mode as applicable.
