



The undersigned is directed to convey the Sanction of the President of India to the payment as part of 1<sup>st</sup> instalment for 1 BLC project comprising constructions of 803 EWS DUs amounting to **Rs. 25,00,000/- (Rupees Twenty Five Lakh only)** to the U.T. administration of Dadra & Nagar Haveli being Central Assistance (Grant) for Capital Creation under PMAY(U) mission for State/UT's Annual Plan 2016-2017.

2. The statement showing details of the projects against which the above amount stand sanctioned towards 1<sup>st</sup> instalment of the Central Assistance is annexed.

3. Based on decision of CSMC in its 19<sup>th</sup> meeting held on 20<sup>th</sup> February, 2017 and on the recommendations made by MoHUPA, the amount of central assistance is being released subject to adhering to the following conditions:

- (i) Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- (ii) The UT administration and implementing agency shall put in place a monitoring system to ensure that the project (s) achieve its scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- (iii) Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme. Otherwise it will have to be refunded along with interest as per provisions for GFR-2005.
- (iv) Furnish the Utilization certificates of the Grant released for the PMAY-HFA (Urban) in the prescribed format as per GFR - 2005.
- (v) Where there is an element of cash transfer the same may be made through PFMS/DBT mode as applicable.
- (vi) UT administration will be required to certify that the specifications of the houses conform to NBC Standards and that requisite infrastructure will be provided by the State Government/ULB.

4. Payment may kindly be made to the U.T. administration of Dadra & Nagar Haveli immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the U.T. administration with interest for the period of default.
