  - iii. These project(s) shall be completed within the period of PMAY(U) (RAY liabilities) for implementation of projects.
  - The State shall utilize the grant in accordance with the approved guidelines for the implementation of the Scheme.
  - v. The State shall provide the State Share in the sharing pattern between the Central Government and the State Government, as per RAY Scheme.
  - vi. The State shall furnish the Utilization Certificates of the Grant released for the RAY in the prescribed format as per GFR 2017.
  - vii. The funds may be utilized for the purpose for which they are given. Otherwise they will have to be refunded along with interest as per provisions for GFR 2017.
  - viii. Where there is an element of cash transfer, the same may be made through PFMS/DBT mode as applicable.
- 4. Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
- 5. The payment is adjustable from the account of the Central Government in the books under the following Head of Account under Demand No. **56** of Ministry of Housing and
