#### **COVID – 19 Protocol in PMAY-U**




States/UTs must ensure compliance to all protocols w.r.t. COVID-19 pandemic and ensure that large construction sites in AHP projects –


- 1. provides all safety measures like masks, sanitisers, gloves to the construction workers
- 2. monitor their vitals daily like temperature, spO2 levels, blood pressure
- 3. provide them with primary care if found symptomatic
- 4. counsel and facilitate the workers and their families about further course of treatment, if required.
- 5. help the eligible on-site workers and their families to get vaccinated.

## **Important decisions**

- Completion of preliminary activities by 25<sup>th</sup> June 2021 for roll out/implementation of revised procedures for release of funds w.e.f 1.7.2021 (Main account at SLNA level and Zero balance account at IA /ULB level) under Centrally Sponsored Scheme (CSS) (BLC, AHP, ISSR)
- 2. Focus should be given on **completion** of approved projects/houses within the stipulated timeline.
- 3. Active Participation in 100 Days Challenge for Awards 2021 (21st June to 30th September 2021)
- 4. The **benchmark** for considering any new proposal for Central Assistance will be:
  - a. Grounding of at least 95% of the sanctioned houses for which funds have been released.
  - b. Completion of 75% of the grounded houses.



## **Critical Compliances**

- ✓ Aadhar seeded beneficiaries in the projects for release of first instalment in BLC Projects.
- ✓ Uploading of **RERA certificate** in PMAY-MIS and **selection of Developer** and issuance of the work order in **AHP** for release of first instalment.
- ✓ Engagement of agencies for TPQM and Social Audit which is critical for release of subsequent instalments.
- ✓ **Completion** of 90% sanctioned houses and **completion certificate** w.r.t projects for claiming of **third instalment**.
- ✓ UC of earlier releases, ATR w.r.t critical observations made by TPQMA and Geotagging.
- ✓ Clearing of all **pending UCs** w.r.t fund released up to **31**<sup>st</sup> **March 2020**.
- ✓ Release of **corresponding State share** (Utilisation of State and Central fund must be reflected in **DBT expenditure**).




#### PMAY-U Awards 2021: 100 Days Challenge (21st June to 30th September 2021)

- ✓ Focus on overall progress in grounding, completion and occupancy of houses sanctioned.
- ✓ 'HFA Achieved' for cities/towns for declaration with in challenge period.
- ✓ Geo-tagging of houses (ensuring photo quality as per the advisory circulated by the Ministry; all Geo-tagged images are in public domain).
- ✓ Cities/Towns for 100% grounding within the challenge period for achieving maximum numbers of cities with 100% grounded houses.
- ✓ **Data compliances** uploading of annexure, beneficiary attachment, address / contact details of beneficiaries etc.
- ✓ **Submit/Upload** Utilization Certificates and ATRs and geo-tagged image of completed houses to claim 3rd instalment through PMAY-MIS
- ✓ **Update of joint ownership** in fastest manner, to become eligible for **Special Category award** on this parameter.
- ✓ **Upload beneficiaries' house photographs** by using PMAY-Urban website/mobile App to strive maximum numbers of photos for Award.





#### Performance in Grounding & Completion against demanded house by States






#### **Performance in Grounding against Houses Sanctions**








#### **Performance in Completion against Sanctions**



- ✓ Development of Dynamic queuing and Service Level Agreement (SLA) for CLSS tracker
- ✓ Ceiling/Capping Home Loan amount to individuals for CLSS subsidy to be followed by CNAs while approving/releasing CLSS subsidy as per RBI guidelines for Affordable Housing (As per RBI/2019-20/176 DOR.No.BP.BC.41/08.12.014/2019-20 dated March 17, 2020 for Financing Affordable Housing upto Rs. 50 lakhs for houses of values upto Rs. 65 lakhs located in the six metropolitan centres viz. Mumbai, New Delhi, Chennai, Kolkata, Bengaluru and Hyderabad and Rs. 40 lakhs for houses of values upto Rs. 50 lakhs in other centres for purchase/construction of dwelling unit per family.)
