# Sub: Release of advance of interest subsidy to National Housing Bank (NHB) under CLSS for EWS/LIG component of PMAY (U).

Sir,

I am directed to convey the sanction of the competent authority for release of ₹3000,00,00,00,00/- (Rupees three thousand crore only) as advance of interest subsidy to National Housing Bank (NHB) being the Central Nodal Agency for implementation of Credit Linked Subsidy Scheme for Economically Weaker Section/Lower Income Group (CLSS for EWS/LIG) component of Pradhan Mantri Awas Yojana – Housing for All (Urban) Mission for making direct release to the Primary Lending Institutions (PLIs) which have signed MoUs with NHB under the scheme, based on the claims submitted by PLIs towards the loans disbursed as per the scheme.

- 2. The release of funds to CNA is further subject to the following terms and conditions:
  - i. The release made by MoHUA shall be kept in a separate designated account for utilization towards the implementation of the scheme and shall not form part of their general financial operations.
  - ii. The money will be utilised only for the purpose for which it has been sanctioned and the interest accrued from the advance released will be credited in the same account of CLSS for EWS/LIG.
  - iii. CNA will exercise requisite checks and due diligence in settlement of claims.
  - iv. CNA will obtain required data and documents from the respective PLI and furnish a utilization certificate towards the release made as soon as possible.
  - v. The subsequent amounts of interest subsidy will be released to CNA after 70% utilization of earlier released amounts, on quarterly basis, and based on claims raised by CNA in the prescribed format (Annexure 3 of the scheme guidelines).
  - vi. PLIs will be given a lump sum amount of ₹3,000/- per sanctioned application in lieu of processing fee for housing loan for the borrower under the scheme. A sum of ₹250/- per sanctioned application would be paid out of scheme funds to the designated staff of ULBs or NGOs or the local agencies identified by the State/ULBs for facilitating the applications from intended beneficiaries.
- vii. 0.1 % of total fund disbursement to the PLIs will be paid to CNA for their administrative expenses for which CNA will furnish the details to MoHUA.
- viii. CNA will submit progress reports including the details of expenditure to MoHUA regularly in the prescribed formats.
- ix. Where there is an element of cash transfer the same may be made through PFMS/DBT mode as applicable.

3. The expenditure involved will be debited under Demand No. 59 of Ministry of Housing & Urban Affairs for the year 2021-22 and will be booked in the following head of account:



#### Credit Linked Subsidy Scheme (CLSS for EWS/LIG) under the Pradhan Mantri Awas Yojana (PMAY) - Release of Advance Subsidy

With reference to the captioned subject, we submit as under:

- At present there is a requirement of funds of about Rs. 9,000 crore for 3.64 lakh Subsidy a. claims already uploaded on NHB's CLSS Portal. Out of this, subsidy claims (2.27 lakh) worth Rs. 5,626 crore have been processed by NHB and they can be disbursed immediately if funds are released to NHB. Furthermore, subsidy claims (1.36 lakh) worth approx. Rs 3365 crore are under process at NHB. As the Scheme is operational till 31st March 2022, the claims from PLIs are likely to increase in future. Accordingly, the claim pending status will be informed to Ministry with respect to position as on 28th March, 2022 separately.
- b. Meanwhile, to meet the immediate requirement for pending subsidy claims, we request release of minimum advance subsidy of ₹3,500 crore (Rupees Three Thousand Five Hundred Crore only) to the following bank account maintained with Canara Bank under intimation to us:

- In the last one year, NHB has brought in process improvements in terms of collecting UCs, c. close follow up of UCs/ refunds, utilisation of additional manpower from other offices, daily monitoring and reporting of utilisation etc. This has resulted in expeditious release of subsidy in September 2021 and January-February 2022. Rigorous follow up will be done in this release also.
- d. The proposed ₹3500 Cr. will be utilised within the indicated 31 days by drawing additional manpower from other offices at the rate of minimum average of ₹100 Cr. per day.
