Please refer to my earlier D.O. letter of even number dated 25th May, 2016 (copy enclosed) requesting all States/UTs to ensure that all implementing agencies set up under the PMAY(Urban)/RAY/JNNURM schemes to be registered by the State Mission Director on the PFMS portal along with maintaining one specific bank account for each scheme. The progress of registration by the implementing agencies under PMAY (Urban) mission of the Ministry of HUPA on the PFMS portal has been slow. So far, only a few State Level Nodal Agencies (SLNAs) have submitted requests for registering on PFMS. There is an urgent need to speed up the progress of registration on PFMS.

2. As a first step, it is requested all the SLNAs (if they have not already registered) should urgently take action for putting in a request on the PFMS portal for registration. The Ministry will be logging in to validate the request. For the purpose of validation by the Ministry, all SLNAs are required to also forward a copy of the details entered on the PFMS portal to the Ministry at the following e mail address: pmaypfms-mhupa@gov.in. The process of registration of all SLNAs on PFMS along with opening a separate/dedicated bank account for the PMAY(Urban) mission is required to be completed by 10th September, 2016 positively.

3. In parallel, all the implementing agencies (along with any intermediate authority through which Central funds are routed) in the PMAY (Urban) mission must necessarily also register on PFMS. It is advised that there should not be more than one intermediary between the State/UT Government and the final implementing agency. The process of validation/approval of all such implementing agencies under PMAY (Urban) on PFMS is the responsibility of the SLNA identified in each State/UT. The process of registration of all the implementing agencies on PFMS along with opening a separate/dedicated bank account for the PMAY(Urban) Mission is required to be completed by 10th October, 2016 positively. In order to avoid delays, in the first instance, all the cities/ULBs which for which project proposals for Central assistance stand accepted by the Ministry, could be given priority in the exercise of registration on PFMS. The rest of the cities/implementing agencies can be taken up in the second stage.

4. Any technical query or assistance required with regard to the process involved in registration on PFMS may be taken up with the officials concerned as indicated in the enclosed D.O. letter. A detailed PPT on the process of registering on PFMS is also enclosed for guidance.

5. I would request your personal intervention for passing necessary directions to the officials concerned to take up the above issues on priority as a decision has been taken to ensure that the flow of funds from the Central Government has to be mandatorily tracked electronically through the PFMS till the stage of the end recipient. Any delay in the registration of all SLNAs/implementing agencies under PMAY(Urban) mission on PFMS could, therefore, result in the avoidable delays in the release of funds from the Ministry under the Mission.

As you are aware, that Public Finance Management System (PFMS) formerly known as Central Plan Scheme Monitoring System (CPSMS) is an online end-to-end system developed by Office of the Controller-General of Accounts (CGA), Ministry of Finance. The System provides common dashboard indicating Sector-wise, Ministry-wise, Scheme-wise, online information of payments/releases made by the Government of India to States, Autonomous Bodies, ULBs and to other Implementing agencies including development authorities and aims at establishing a suitable online Management Information System and decision support system for the Plan Scheme of the Government of India. As Pradhan Mantri Awas Yojana (PMAY) (Urban), RAY and JNNURM schemes are under ambit of DBT, it has become imperative that all States/city level implementing agencies are on PFMS to ensure tracking of funds at all stages.

2. Further, PFMS has been implemented to make electronic payment, both, Plan and Non-Plan by Ministry of Housing and Urban Poverty Alleviation (HUPA). PFMS also enable tracking of funds released from Government of India to report on status of unspent funds lying at various levels in the implementing agencies and floats available in the bank. This facility can help in reduction in unnecessary parking of funds and lead to better fiscal management, cash management and reduce debt burden to GOI.

3. It has been decided by the Ministry of HUPA that the accounts of all the implementing agencies set up under the PMAY(Urban) Mission/RAY/JNNURM Schemes of M/o HUPA should be integrated with PFMS, so that the online monitoring fund utilization can be ensured.

4. In view of above, all implementing agencies handling funds under the above schemes in the State need to be registered by the State Mission Director, on PFMS portal alongwith maintaining one specific bank account for each scheme i.e the bank account kept for specific scheme should deal with transaction of only that particular scheme.
