Minutes of the 23<sup>rd</sup> meeting of the Central Sanctioning and Monitoring Committee (CSMC) under Pradhan Mantri Awas Yojana (Urban)- Housing for All Mission held on 21<sup>st</sup> June, 2017

The 23<sup>rd</sup> meeting of the Central Sanctioning and Monitoring Committee (CSMC) under Pradhan Mantri Awas Yojana (Urban) [PMAY(U)] was held on 21<sup>st</sup> June, 2017 at 2:30 P.M. in Conference Hall, NBO- Nirman Bhawan, New Delhi, with Secretary, Ministry of Housing and Urban Poverty Alleviation in chair. The list of participants is at **Annexure-I**.

- 2. At the outset, Secretary (HUPA) welcomed the participants/representatives from the State Governments, participants/officers of the Ministry and other Departments.
- 3. Thereafter, Joint Secretary (HFA) introduced the agenda for the meeting. The agenda items also form part of the minutes. The item wise minutes are recorded as follows:

- 4.1 The minutes of the **22<sup>nd</sup> CSMC** meeting under PMAY (U) held on 29<sup>th</sup> May, 2017, were confirmed without any amendments.
- Consideration for the proposal for Central Assistance for 2 Affordable Housing in Partnership (AHP) projects, 1 Beneficiary Led Construction (New) project and 1 Beneficiary Led Construction (Enhancement) project submitted by Union Territory of Andaman & Nicobar Islands (Agenda 1)

#### A. Basic Information:

The proposal for consideration of CSMC was for Central Assistance for 2 Affordable Housing in Partnership (AHP), 1 Beneficiary Led Construction (New) and 1 Beneficiary Led Construction (Enhancement) projects submitted by Union Territory of Andaman & Nicobar Islands. #### B. Additional information by the State:

- i. The total demand as per demand survey is for 670 houses.
- ii. HFAPoA and AIP have already been submitted and will be entered in MIS soon.
- iii. The recruitment process for SLTC will be initiated after funds are released. No CLTC is necessary since there is only one mission city. U.T. Admn. sought assistance for recruitment of professionals for SLTC for Port Blair.
- iv. The U.T. has accomplished 3 mandatory reforms. With regard to reform No. 4, the ULB is in the process of releasing pre-approved design which is expected to be completed by 31st July 2017. Considering the land pattern and non-availability of large chunk of land for such schemes, at present there is no proposal for additional FAR (Reform No.6). The U.T. Admn. is taking up matter with the Ministry of Home Affairs.
- v. Survey data is yet to be entered into PMAY-MIS portal.

#### C. CSMC observations:

- i. The ULB to make sure that all beneficiaries are willing to contribute their share for construction of houses.
- ii. The construction of BLC (New) houses should be completed by the beneficiaries upto plinth level with their own fund before funds are transferred to beneficiaries.
- iii. Encumbrance free land to be made available after transfer of land title to Andaman & Nicobar Administration by the competent authority.
- iv. Since the construction cost of the houses are quite high in Port Blair, UT of Andaman & Nicobar may consider its own contribution in the projects as was done by the other UTs namely Daman & Diu, Dadra Nagar Haveli and Puducherry.



- v. The BLC-Enhancement projects proposed are not as per extant guidelines and need to be revised.
- vi. The unutilized GoI fund released under JNNURM may be refunded immediately with applicable interest.

#### **D. CSMC Decisions:**

In view of the above, the CSMC:

- (i) accorded "in principal" approval for Central Assistance amounting to Rs. 8.565 Crore for 2 AHP Projects submitted by the Union Territory of Andaman & Nicobar Islands for construction of 571 houses in EWS category under PMAY (U) as per details at **Annexure II-A**
- (ii) accorded approval for Central Assistance amounting to Rs. 0.57 Crore for 1 BLC (New) Project submitted by Union Territory of Andaman & Nicobar Islands for construction of 38 houses in EWS category under PMAY (Urban) as per details at **Annexure II-B.**
- (iii) recommended for release of the first instalment of central assistance amounting to Rs. 0.228 Crore (40% of central assistance) for the BLC(New) project of Union Territory of Andaman & Nicobar Islands subject to compliances as indicated in Para 5C (i) and 5(C)(ii) prepage.
- (iv) Deferred the proposal for BLC-Enhancement since the specifications of the proposed houses do not conform to PMAY guidelines for BLC (Enhancement) projects.
- Release of 2<sup>nd</sup> instalment for Pilot DPR for Leh old Town Upgradation under RAY, JAMMU & KASHMIR (Agenda-2)

#### A. Basic Information:

The proposal for consideration of CSMC was for release of 2nd instalment under RAY for Leh Old Town Upgradation project submitted by the State Government of Jammu & Kashmir. Brief details of the project are as under:

- i. The RAY project was approved by the CSMC in its 6<sup>th</sup> meeting held on 11.01.2013 with a total project cost of Rs. 2221.88 lakh comprising Central Share of Rs. 1781.18 lakh.
- ii. Later on as per the revision in funding pattern from 90:10 to 80:20, State Govt. of J&K [Housing and Urban Department], vide SLSMC meeting dated 28.01.2014 under the Chairmanship of Hon'ble Minister of Urban Local Bodies, revised the Central Share to Rs. 1597.57 lakh. Accordingly, the Central Share of every component of the project was revised including the components of Water Supply [revised to Rs. 414.16 lakh] and O&M charges [revised to Rs. 32.17 lakh]. In view of this, the 1<sup>st</sup> installment of Rs. 626.15 lakh (40% of revised ACA of Rs. 1597.57 lakh) was released to the State of J&K, vide Sanction order dated 24.02.2014.

- During visit of Ministry officials, it was noticed that the part funding of water supply component was done by UIDSSMT Scheme of MoUD. The project cost for the water supply component was accordingly revised to Rs. 115 lakhs from Rs. 414.16 lakhs. The Project cost (excluding O&M, Consultancy/Contingency charges) revised to Rs. 1554.05. Accordingly, the central share for water supply component was revised to Rs. 92.00 lakhs [80% of Rs. 115 lakh] and for O&M charges component was revised to Rs. 24.86 lakh [80% of (2% of 1554.05)].
- iv. In the above background, the details of 2<sup>nd</sup> installment to be released are as under:

With regard to implementation of this project, it was also intimated that the Indian National Trust for Art and Cultural Heritage (INTACH), New Delhi had raised an objection regarding large scale demolition of heritage buildings in the historic Leh town being undertaken under the RAY Pilot Project. A communication in this regard was received from Chairman/Chief Executive Councilor, Ladakh Autonomous Hill Development Council (LAHDC) conveying therewith that the assertion of INTACH about large scale demolition of heritage buildings in the town is not correct. The representation of INTACH alongwith the comments of Chairman/Chief Executive Councilor, LAHDC were also forwarded to the Govt of J&K for requisite comments from the competent authority of the State Govt. The Govt. of J&K has reiterated the position of DDC, Leh and comments of ASI representative that all the guidelines are being followed in implementation of the project.

Further, the Ministry officials have also conducted a site scrutiny visit of the project and have held a meeting with all the stakeholders including ASI and INTACH officials. As per the minutes of the meeting, ASI and INTACH have expressed their satisfaction regarding works already completed and fulfillment of relevant ASI guidelines.

vi. In view of above, the matter of 2<sup>nd</sup> installment of Rs. 368.442 lakhs for above mentioned RAY project for the State of Jammu & Kashmir was proposed before CSMC.

#### **B. CSMC Observations:**

- i. The financial progress is above 70% as required for release of 2<sup>nd</sup> installment, however, overall physical progress is about 35%.
- ii. BMTPC may recalculate the physical progress achieved both in housing and infrastructure in the project and submit its comments immediately.

#### C. CSMC Decision:

In view of the above, the CSMC:

- (i) accorded approval for the release of 2nd instalment of central assistance of Rs. 368.44 lakhs to the State Government of Jammu & Kashmir for 1 RAY project for Leh Old Town upgradation as per the **Annexure III** subject to submission of satisfactory physical progress report by BMTPC;
- (ii) directed that the cost of water supply funded by UIDSSMT should be deducted from the overall project cost and ACA be accordingly updated in MIS.
- (iii) directed that the ACA will be released/adjusted against excess release, if any, and as per revised funding pattern, and
- (iv) also directed that State Government to ensure that ASI is kept informed about the progress of the work so that construction of works being carried out is in compliance with the Ancient Monuments and Archaeological Site and Remains Act 1958 and Ancient Monuments and Archaeological Site and Remains (Amendment & Validation) Act, 2010.
- 7. Consideration for Central Assistance for 50 Beneficiary Led Construction (New) projects submitted by State of Uttar Pradesh. (Agenda 3)

#### A. Basic Information:

The proposal for consideration of CSMC was for Central Assistance for 50 Beneficiary Led Construction (New) projects submitted by State of Uttar Pradesh. The salient details of the proposal are as under:

#### B. Additional information given by the State:

- i. Demand survey has been completed in all the 628 approved cities and data has been verified in 199 cities by respective PO, DUDA and EO of ULBs.
- ii. Total demand is 31,07,788 out of which 11,09,379 applications have been received through CSC and online. HFAPoAs/ AIPs are under preparation.
- iii. All the 13,894 beneficiaries of the instant proposal have been validated and found eligible as per PMAY guidelines.
- iv. Two pre-approved model designs and layouts conforming to NBC have been proposed depending on the earthquake prone zones and type of foundation strata. Different layout designs will be prepared to construct the houses with innovative technologies and material using natural resources. Minor variation depending upon size and shape of the land would be done. ULBs will monitor and approve the changes as required, if any.
- v. The beneficiary share is Rs.0.71 lakh and Rs.1.47 lakh per house which include labour and materials.
- **vi.** Central and State funds will be transferred to the beneficiary after completion of work till plinth level by them.
- vii. It has been proposed to avail of loan from HUDCO to meet the State share under PMAY(U).
- viii. The target for the year 2017-18 is for 5.40 lakh EWS houses. Project proposals for 2 lakh EWS houses under BLC and 2 lakh EWS houses under AHP would be submitted up to December 2017. Efforts are also being made for preparing projects under ISSR vertical of PMAY (U).

#### C. CSMC observations:

- i. None of the houses approved earlier have been grounded so far. State Government should expedite construction of houses and funds released under PMAY (U) should not be parked in State Treasury.
- ii. State to ensure that:
  - Occupancy of houses completed under JNNURM before submitting proposal under PMAY(U) for concerned ULBs.
  - Progress of work is expedited so that the approved projects are completed within the scheduled timeline.
  - Adequate infrastructure is provided including individual water, sanitation and electricity connections.
  - There should be no duplication/change in the identified beneficiaries.
  - Demarcation of land and mutation is carried out before implementation.
  - The design and construction of houses is disaster resilient and the specifications conform to IS/ NBC norms.

#### D. CSMC Decision

In view of the above, the CSMC:

- (i) accorded approval for Central Assistance amounting to Rs. 208.410 Crores for 50 projects under BLC (New) submitted by the State Government of Uttar Pradesh for construction of 13,894 houses in EWS category under PMAY (Urban) as per details at **Annexure IV**.
- (ii) recommended for release of the first instalment of central share amounting to Rs. 83.364 Crores (40% of central assistance) for the 50 BLC (New) projects of Uttar Pradesh.
  - Ratification of number of beneficiaries for the 32 BLC (N) projects under PMAY (U) approved in 17<sup>th</sup> CSMC meeting for the State of Uttar Pradesh (Agenda 4)

#### A. Basic Information:

- (i) The proposal for construction of 10,425 houses under 32 BLC (N) projects under PMAY (U) was considered in 17th CSMC when CSMC recommended for (a) release of the first instalment of Central Assistance amounting to Rs. 45.834 Crores (40% of central assistance) for the 32 projects under BLC (New) for construction of 7639 houses in EWS category for the validated beneficiaries whose consent and land documents had been received by the State and that (b) the 1<sup>st</sup> instalment of Central Assistance amounting to Rs. 16.716 Crores (40% of central assistance) for the remaining 2786 houses in EWS category would be released after the certification from the State Government of Uttar Pradesh that the consent and land documents from the eligible beneficiaries have been received.
- (ii) The State Govt. of Uttar Pradesh, <u>vide</u> its SLSMC minutes, dated 26.05.2017 has intimated that out of 10,425 beneficiaries approved by the 17<sup>th</sup> CSMC, land documents of only 9401 beneficiaries have been validated. With regard to remaining 1024 beneficiaries, it has further been informed that due to non-submission of land related documents by the beneficiaries these 1024 DUs have been dropped in the projects.
- (iii) Out of these 32 projects, State Govt. of U.P. with the approval of SLSMC has revised the number of beneficiaries only in 14 projects. The remaining 18 projects remained unchanged as approved in the 17<sup>th</sup> CSMC meeting.

#### **B. CSMC Observations:**

- (i) State should confirm and validate beneficiaries before finalising projects in BLC vertical.
- (ii) Availability of proper land title of the beneficiary, consent of the beneficiary with regard to its share etc. may also be confirmed during validating the beneficiary.

#### C. CSMC Decision

In view of the above, the CSMC:

- i. ratified the revised number of beneficiaries as 9401 and dropped 1024 beneficiaries as proposed by the State of Uttar Pradesh as per **Annexure V.**
- ii. accorded approval for <u>revised Central Assistance</u> amounting to Rs. 141.015 crores for 9401 EWS houses only in the 32 BLC (N) projects, considered in 17<sup>th</sup> CSMC meeting.
- iii. recommended for release of revised 1<sup>st</sup> installment amounting to Rs. 56.406 crores. The fund released earlier (Rs. 45.834 crore as per approval in 17<sup>th</sup> CSMC) may be released/adjusted accordingly.
- 9. Consideration of Central Assistance for 1 'Beneficiary Led House Construction' (New) and 117 Affordable Housing in Partnership (AHP) projects submitted by State of Karnataka (Agenda No. 5)

- i. Demand Survey in 214 cities is complete and total demand assessed is 14 lakh of which applications received through CSC is 3.46 lakh and through citizen online is 5.63 lakh. Preparation of HFAPoAs is under progress.
- ii. ULBs and KSDB are conducting demand survey in newly upgraded 57 ULBs.
- iii. State will prepare AIP keeping in view available resource and priority.
- iv. Out of the 6 mandatory reforms under PMAY (U), the State has achieved 2 and in respect of 3 reforms, these are under process at State Government level.
- v. 4 project proposals as under were submitted in which two cities were clubbed to ease the administrative process.

- vii. **Progress:** Out of 56 projects (37,797 houses) approved earlier under AHP, work order issued for 19 projects, out of which work in 17 projects (14,612 houses) are in progress. Tender have been issued for 10 projects (9741 houses) and administrative approval is in process for 18 projects.
- viii. Further, out of 84,957 houses approved earlier under 652 BLC projects, 4932 houses have been completed; and work commenced in 15,051 houses.
- ix. **CLSS:** Subsidy has been released to 835 beneficiaries through NHB.
- x. Innovative technology Adopted: A Fast Track Monolithic Shear Wall Technology is adopted in few projects of KSDB under AHP vertical of PMAY:HFA(U)-2022. The Project will be completed well within the stipulated time with high quality of construction against floods and natural calamities with safe design strength.
- xi. **Details of IEC initiatives:** A training programme was organized for all MIS experts to enhance the capacity. It was also planned to organize a workshop/training to all engineers working under the projects in association with BMTPC in 2017-18.

#### C. Observation of the CSMC

i. One project (68 houses) at **Kempanahalli Gram Panchayat** (not included as HFA city) has been proposed by RGRHCL. Also, there are 7 proposals (8 cities) in which the number of houses are less than 200. It was decided not to consider these proposals and

- advised the State representative to resubmit the revised proposals with additional houses from slum/non slum area and the Kempanahalli project may be resubmitted only when it is notified as a planning area with reference to a statutory town.
- ii. In 4 project proposals, two towns each have been proposed. These have been revised into 4 project proposals in 4 separate towns. It was decided that cities in which the number of houses are more than 200 shall be taken up as separate project in accordance with para 6.4 of the guidelines and on the basis of request from State Government. The remaining cities are to be taken up only when proposed number of EWS houses are more than 200.
- iii. State is also to ensure that:
  - a. Adequate infrastructure is provided including individual water, sanitation and electric connection.
  - b. There should be no duplication/change in the identified beneficiaries.
  - c. Demarcation of land and mutation is carried out before implementation.
  - d. The design and construction of houses is disaster resilient and the specifications conform to IS/ NBC norms.

#### D. CSMC Decision

In view of the above, the CSMC:

- (i) accorded approval for Central Assistance amounting to Rs. 0.195 Crores for 1 BLC (New) Project submitted by the State Government of Karnataka for construction of 13 houses of EWS category under PMAY (Urban) as per details at **Annexure VI A**.
- (ii) accorded approval for Central Assistance amounting to Rs. 844.02 Crores for 110 AHP Projects submitted by the State Government of Karnataka for construction of 56,268 houses of EWS category under PMAY (Urban) as per details at **Annexure VI B**
- (iii) recommended for release of the first instalment of central assistance amounting to Rs. 0.078 Crores (40% of central assistance) for the 1 BLC (New) project of Karnataka.
- (iv) recommended for release of the first instalment of central assistance amounting to Rs. 337.608 Crores (40% of central assistance) for the 110 AHP projects of Karnataka.
- Consideration for cancellation of 20,060 houses in 197 BLC (New) projects considered in 11<sup>th</sup> CSMC meeting submitted by the State of Karnataka (Agenda 6)

### A. Brief Information:

The State Government of Karnataka has proposed for cancellation of 20060 houses in 197 projects (except Gadag BLC project) out of 198 projects considered for Central Assistance in

11<sup>th</sup> CSMC meeting held on 11.8.2016 and proposed for retention of 530 houses in 17 projects (out of the 197 projects). The SLSMC in its 7<sup>th</sup> meeting held on 26.05.2017 had approved cancellation of 20060 DUs due to non-validation of beneficiaries.

#### B. CSMC Observations:

The CSMC observed that the State has given only number of houses to be retained in 17 projects out of 197 projects approved in 11<sup>th</sup> CSMC, but details such as project cost, State/ULB/Beneficiary share etc. have not been mentioned. This information is required in the Ministry.

#### C. CSMC Decision:

The proposal was deferred and State Government was directed to furnish project-wise details of Project Cost, State/ULB/Beneficiary share in the projects proposed for retaining with reduced number of houses for consideration of CSMC.

Consideration for replacement of Capacity Building Specialist and Urban Planner in CLTCs with Social Development Specialist and Municipal Finance Expert respectively, for Annual Capacity Building Plan 2016-17, submitted by the State of ASSAM (Agenda 7)

#### A. Basic Information:

The proposal was for replacement of Capacity Building Specialist and Urban Planner in CLTCs with Social Development Specialist and Municipal Finance Expert respectively, for Annual Capacity Building Plan 2016-17, which has been approved by SLSMC. State Govt. has confirmed that the qualification for Social Development Specialist and Municipal Finance Expert will be Graduate and Post Graduate respectively as was for Capacity Building Specialist and Urban Planner respectively as earlier proposed by State Govt. and approved by Ministry of HUPA. Hence, there will be no change in grant of Central Assistance and the proposal does not involve any financial implication.

#### **B. CSMC Observations:**

1st CSMC has already approved the nomenclature of experts for SLTC & CLTC.

#### C. CSMC Decision:

Given the decision of 1st CSMC, the directions incorporated in such decision are to be followed.

Consideration for reimbursement of expenditure incurred by National Housing Bank in respect of the 10 workshops held in various cities on CLSS in relaxation of the existing norms laid down by CSMC (Agenda 8)

#### A. Relaxation of expenditure i/r of Workshops in various cities on CLSS

The Committee considered the facts placed before it and in that light noted that there is considerable justification in considering a relaxation of the extant norms under which the reimbursement proposals for the workshops held by NHB were considered. Accordingly, CSMC agreed to the proposal for reimbursement of Rs. 1,80,564/- towards the workshops held at 10 cities i.e. Lucknow, Patna, Srinagar, Trivandrum, Ranchi, New Delhi, Ahmadabad, Kolkata, Kohima and Ernakulum being the amount due to NHB in excess of the approved norms as a onetime relaxation.

#### **B** CSMC Decision:

12

In view of the above, the CSMC approved and recommended Rs. 1,80,564/- being difference between the expenditure admissible under the then prevalent norms and as admissible under the extant norms for workshops under CLSS to NHB.

Discussion on Credit Linked Subsidy Scheme

#### 1. Andaman and Nicobar Islands

The representative of the UT informed that 84 potential beneficiaries have requested for benefit under CLSS through applications, after an awareness drive was carried out in Port Blair. The representatives of CNAs informed that SBI and Vijaya Bank are actively following up on home loan applications from potential beneficiaries.

#### 2. Uttar Pradesh

The representative of the State Government informed that considerable response has been received in Loan Melas being organized by Awas Vikas Parishad. Secretary (HUPA) directed that a concerted effort for CLSS be made in the State with the participation of a larger number of HFCs as the potential beneficiaries under CLSS for EWS/LIG indicated by the demand assessment is 4 lakhs.

#### 3. Karnataka

The representative of the State Government informed that it is examining execution of tri-partite agreements between local bodies, lenders and beneficiaries to increase offtake of built up units. For this purpose, a discussion was held with NHB also. It was also informed that the State Government will take up the issue of lack of participation of PSBs in the State with SLBC.



The following important observations were made regarding project proposals under PMAY (U). States should take note of the observations of CSMC and take further action accordingly:

- i. It was suggested that States and UTs share good quality images of the housing for documentation of case studies. It was also advised to document success stories of the PMAY (U) projects which highlights a tangible change in the livelihood of the beneficiates due to this programme.
- ii. MoHUPA will document, film and disseminate the good practices through its quarterly newsletters.
- iii. The States were advised to incorporate latest technology in construction of housing units and document the same.
- iv. A robust MIS System is critical for PMAY (U) Mission. States need to constantly monitor the progress of survey data entries and link to sanctioned projects in PMAY (U)-MIS.
- v. The agencies responsible for implementation of PMAY should get themselves registered on Public Finance Management System (PFMS) portal.
- vi. Under PMFS/DBT process, the funds would have to be transferred at every stage only through electronic mode. This may relate to PMAY as under:
  - a. In case of Centrally Sponsored Schemes:
    - For Beneficiary Led individual house Construction (BLC), under PMAY (Urban), the bank account details of the beneficiaries should necessarily be mapped so that the funds can flow to the beneficiaries' bank account directly.
    - 2. In the case of Affordable Housing in Partnership (AHP) and In-Situ Slum Redevelopment (ISSR) projects under PMAY (U), the 2nd instalment to the State Government should be released only after receipt of beneficiary list with linkage of Aadhaar numbers of the beneficiaries duly certified by the State Government/ UT concerned and uploaded in the PMAY- MIS portal.
  - b. In case of Central Sector Scheme:
    - 1. for CLSS, the Central assistance is deposited upfront in the loan account of the beneficiary, after the bank receives the funds from CNAs
- vii. State Level Appraisal Committee is expected to thoroughly appraise the DPRs before submitting it to State Level Sanctioning & Monitoring Committee for approval. Combining SLAC and SLSMC meeting is not permissible as the mandate of the two bodies are distinct.
- viii. Projects such as VAMBAY, JNNURM, which have already been funded under housing schemes of GoI should not be considered for further funding under PMAY (U).
- ix. Under BLC, all individual houses shall have to be Geo-tagged on the BHUVAN (MoHUPA) application. Further, the States are advised to release funds to the

- beneficiary only after the beneficiary completes the construction up to foundation level through their own funds.
- x. It was suggested that process of Aadhaar Payment Bridge (APB) be initiated for transfer of installments to the beneficiaries subject to guidelines of Ministry of Electronics & Information Technology (MeitY)/ Unique Identification Authority of India (UIDAI) in this regard.
- xi. It has come to notice that some individual/organizations are collecting registration money etc. from potential beneficiaries seeking dwelling units in PMAY (U). The Ministry of Housing and Urban Poverty Alleviation has not authorized any individual/organization/agency to collect application/registration fee for applying for DUs in PMAY (U). Thus, no individual/agency/organization can collect any money/application fee from the beneficiary for enrolment under PMAY (U). All State Governments may also issue disclaimer to this effect in their relevant websites/advertisements etc. to stop this fraudulent activity.
- xii. BMTPC to come out with a standard layout for BLC projects for all States/UTs.
- xiii. Since Rajiv Awas Yojana (RAY) is subsumed in Pradhan Mantri Awas Yojana PMAY (U), Third Party Quality and Monitoring Agencies (TPQMA) appointed for PMAY (U) may also certify quality aspects of RAY projects.
- xiv. All states should utilize the released central funds before September, 2017 and avoid parking of funds.


