Preparedness of distribution of Abadi Patta



- So far total 24961 BLC houses have been sanctioned for beneficiaries residing on Abadi Bhumi, wherein the beneficiaries are eligible under PMAY but ownership documents are not available.
- ["] To distribute patta (permanent lease deeds) to households located on Abadi Bhumi a state wise survey has been carried by District Collectors and a validated list of approx. 1 lakh households has been prepared for distribution of Abadi Patta to such households in Urban areas.
- ["] The distribution of Abadi patta in Urban areas will begin from 2nd week of May and will be distributed across the state with one month time.
- Post distribution the ULBs will allow the construction of sanctioned BLC houses on Abadi Bhumi.
