








Overall Progress based on Demand Survey








- ▶ TPQMA engaged for periodic monitoring of the construction of DUs on a sample basis with the mandate to visit at least 3 (thrice) during different stages of the construction.
- ▶ TPQMA has completed 3 (three) visits for FY 2015-16 and 2 visit of 2016-17 & 2 visit for FY 2017-18.
- ▶ It is in the process of completing the 1st visit for FY 2018-19.
