- iii. Remaining 50% of Central Assistance would be released subject to submission of City-wise list of Social Audit Committee members, copy of sample tools used for Social Audit & State Level Social Audit report, duly signed by the State Mission Director/competent authority.
- iv. Further, remaining 50% of Central Assistance would be released as per actual and on receipt of Utilization Certificate along with Undertaking (in prescribed format mentioned in Capacity Building Activities - Norms, Fund Disbursal Processes and Plan Templates) from the States.
- The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- vi. The State will utilize the sanctioned grant for the purpose for which it is released.
- The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-U.
 - ix. Where there is an element of cash transfer, if any, the same may be made through DBT/EAT module of PFMS as applicable.
