Sir,

I am directed to convey the sanction of the Competent Authority to the release of ₹1,62,22,500/- (Rupees One Crore Sixty Two Lakh Twenty Two Thousand and Five Hundred only) as 2nd and final installment of Central Assistance (25%) to State Govt. of Assam for Housing for All Plan of Actions (HFAPoAs) for 96 ULBs/towns under Pradhan Mantri Awas Yojana - Urban (PMAY-U) Mission. The details of said release are at Annexure.

- 2. Earlier, fund of ₹76.34 lakh was released to State Govt. of Assam for preparation of Slum Free City Plan of Action (SFCPoA) under Rajiv Awas Yojana (RAY) vide sanction letter No. 59(8)/PF-I/2009-829 dated 31.03.2010. Additionally, fund of ₹491.405 lakh (₹448.88 lakh for 88 ULBs/towns and ₹42.525 lakh for 9 ULBs/towns) was released to State Govt. of Assam as 1st installment of Central Assistance for preparation of HFAPoAs for 97 ULBs/towns under PMAY-U Mission vide sanction letters dated 09.09.2016, 30.09.2016 and 06.03.2017. State Govt. of Assam has submitted Utilization Certificates (UCs) for the entire amount of ₹76.34 lakh released for preparation of SFCPoA under RAY and for the entire amount of ₹491.405 lakh released for preparation of HFAPoAs under PMAY-U Mission as detailed above, which are enclosed herewith.
- The funds received by State Govt. of Assam as 1st installment of Central Assistance 3. for preparation of HFAPoAs for 96 ULBs/towns, were released directly to ULBs. State Govt. of Assam has submitted 96 HFAPoAs which were placed before Central Sanctioning and Monitoring Committee (CSMC) in its 52nd and 54th meetings and CSMC has taken note of the HFAPoAs submitted by the State Govt.
- 4. The above grant is subject to the following conditions:
 - The State will utilize the sanctioned grant for the purpose for which it is released. The i. State will also furnish the Utilization Certificate as per GFR 2017.
 - ii. The above release is only for those cities which are approved by this Ministry under HFA Mission, as detailed at Annexure.
- The State will comply with the terms and conditions stipulated in the guidelines, iii. CSMC directions and instructions issued by this Ministry.
- The State Government/Nodal Agency shall strictly monitor the progress of the İ۷. preparatory work.
- The amount Central Assistance approved will form a part of capacity building plan of ٧. the state under PMAY-U Mission.

- vi. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.
