Sub.: Release of Rs. 8.25 lakh as 1st instalment of Central Assistance to State Govt. of Gujarat for FY 2019-20, 2020-21 and 2021-22 for conducting Social Audit under Capacity Building Activities of PMAY-U Mission – reg.

Sir,

I am directed to convey the sanction of Competent Authority to release an amount of **Rs. 8,25,000/- (Rupees Eight Lakh and Twenty Five Thousand Only)** to State Govt. of Gujarat for FY 2019-20, 2020-21 and 2021-22 as 1st instalment of Central Assistance for conducting Social Audit (SA) under Pradhan Mantri Awas Yojana – Urban (PMAY-U) Mission. The details of release are as under:

2. State Govt. has submitted documents mandated for release of 1st installment of Central Assistance for Social Audit i.e. copy of EoI Notification used for selection of IFA and city-wise list of projects along with the number of dwelling units selected wherein Social Audit will be conducted.

3. The above grant is subject to the following conditions:

- i. The States will conduct Social Audit as per the Capacity Building Guidelines issued by the Ministry.



- ii. 5-10% of the approved projects are to be selected for Social Audit with minimum size of at least 100 Dwelling Units (DU) grounded with beneficiaries identified.
- iii. Remaining 50% of Central Assistance would be released subject to submission of City-wise list of Social Audit Committee members, copy of sample tools used for Social Audit & State Level Social Audit report, duly signed by the State Mission Director/ competent authority.
- iv. Further, remaining 50% of Central Assistance would be released as per actual and on receipt of Utilization Certificate along with Undertaking (in prescribed format mentioned in Capacity Building Activities - Norms, Fund Disbursal Processes and Plan Templates) from the States.
- v. The States will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- vi. The States will utilize the sanctioned grant for the purpose for which it is released.
- vii. The State Governments/Nodal Agency shall strictly monitor the progress of the preparatory work.
- viii. The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-U.
- ix. Where there is an element of cash transfer, if any, the same may be made through PFMS/DBT mode as applicable.

4. The amount involved is debitale to the following Head of Account under Demand No. 59 of the Ministry of Housing and Urban Affairs for the year 2021-22:

6. This being the first instalment of Central Assistance, no UC is required/due for above release.

As per rule 236(1) of GFR, 2017, the relevant accounts of the Grantee Institution(s)/Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.

9. The sanction has been registered at **S. No. 427** of the Grants-in-Aid Register of the HFA Division for the year 2021-22.


