Sub: Release of ₹165.375 lakh to State Govt. of Punjab as 2nd and final instalment of Central Assistance for preparation of HFAPoAs for 120 cities under Capacity Building activities of PMAY-U Mission - reg.

Sir.

I am directed to convey the sanction of the Competent Authority to the release of ₹1,65,37,500/- (Rupees One Crore Sixty Five Lakh Thirty Seven Thousand and Five hundred only) to State Govt. of Punjab as 2nd and final instalment of Central Assistance (25%) for preparation of Housing for All Plan of Actions (HFAPoAs) for 120 cities under Capacity Building activities of Pradhan Mantri Awas Yojana - Urban (PMAY-U) Mission under SLS PB320 - 1989-PRADHAN MANTRI AWAS YOJANA (PLAN OF ACTION). The details of said release are at Annexure.

- 2. Earlier, fund of ₹728.44 lakh was released to State Govt. of Punjab as 1st installment of Central Assistance for preparation of HFAPoAs for 163 cities under Capacity Building activities of PMAY-U Mission vide sanction letter No. N-11036/17/2016/HFA.I (FTS-15345) dated 19.05.2016. State Govt. of Punjab has submitted the entire Utilization Certificate (UC) against the said release, which is enclosed herewith.
- State Govt. of Punjab has submitted 120 HFAPoAs which were placed before Central 3. Sanctioning and Monitoring Committee (CSMC) in its 44th meeting held on 28.06.2019 and CSMC has taken note of the HFAPoAs submitted by the State Govt.
- 4. The above grant is subject to the following conditions:
 - i. PMAY-U being a Centrally Sponsored Scheme (CSS), the State Govt. should strictly follow the revised procedure of fund flow as per O.M. No. 1(13) PFMS/FCD/2020 dated 23rd March 2021 issued by Department of Expenditure, Ministry of Finance, Government of India and subsequent instructions issued in this regard. These instructions have been made effective from 1st July 2021 which inter-alia provides that
 - a. Based on the authorization, the State Govt. shall transfer the Central Assistance as well as commensurate State share to the Single Nodal Account (SNA) within 30 days of receipt of Central Assistance failing which penal interest at the rate of 7% per annum will be charged on the number of days of delay beyond 30 days in transfer of Central Assistance to the SNA account.
 - Central Assistance along with State share are to be kept by the Nodal Agency b. in the Single Nodal Account (SNA) opened in a Scheduled Commercial Bank for the purpose and the same is mapped in PFMS. The nodal agency will allocate drawing limits to IAs having zero balance subsidiary accounts duly mapped in PFMS and linked to SNA account for drawal of funds on real time basis from the Single Nodal Account.

- c. The nodal agency shall ensure that the interest earned from the funds released, should be mandatorily remitted to respective consolidated funds on pro-rata basis in terms of rule 230(8) of GFR 2017.
- d. SNAs and IAs will mandatorily use the DBT/EAT module of PFMS or integrate their systems with the PFMS to ensure that information on PFMS is updated by each IA at least once every day.
- e. SNA will keep all the funds received in the Single Nodal Account only and shall not divert the same to Fixed Deposits/Flexi-Account/Multi-Option Deposit Account/Corporate Liquid Term Deposit (CLTD) Account etc.
- f. Further releases under the scheme will be made only after transfer of entire Central Assistance released till date along with corresponding State share in the SNA account and utilization of 75% of earlier releases along with corresponding State share.
- ii. The State will utilize the sanctioned grant for the purpose for which it is released. The State will also furnish the Utilization Certificate as per GFR 2017.
- iii. The above release is only for those cities which are approved by this Ministry under HFA Mission, as detailed at **Annexure**.
- iv. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- v. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- vi. The amount Central Assistance approved will form a part of capacity building plan of the state under PMAY-U Mission.
- vii. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.
- 5. The Expenditure is debitable to the following Head of Account under Demand No. 60 of Ministry of Housing and Urban Affairs (MoHUA) for the financial year 2024-25:
