I am directed to convey the mother sanction of the competent authority for release of **Rs. 1,21,90,020/- (Rupees One Crore Twenty One Lakh Ninety Thousand and Twenty only)** to State Govt. of Assam on account of revalidation of lapsed amount of mother sanction of Rs. 168.60096 lakh issued in FY 2024-25 through SNA SPARSH vide sanction letter of even number dated 06.12.2024, as balance amount of 1<sup>st</sup> installment of Central Assistance along with 2<sup>nd</sup> installment of Central Assistance for conducting TPQM for the projects sanctioned up to March 2024 under Capacity Building activities of Pradhan Mantri Awas Yojana - Urban (PMAY-U) Mission for FY 2025-26 under SLS AS304 - Pradhan Mantri Awas Yojana - Housing for All - Urban - Assam through SNA SPARSH. 4. This admissible Central liability will be released to the Government of Assam on demand through SNA SPARSH only or/and as per the latest guidelines of DoE. As the State has on-boarded on SNA SPARSH, all the committed liabilities shall be released in SNA SPARSH only. The State Government is required to contribute approved matching State share under the scheme. State to ensure timely release of matching State share.

5. As per rule 236(1) of GFR 2017, the relevant accounts of the Grantee institution(s)/Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.


