Sir.

I am directed to issue the Mother sanction, with the approval of competent authority, to release ₹1,00,00,000/- (Rupees One Crore only) under SNA Sparsh to the State Govt. of Meghalaya against the Central assistance available in SNA account of the State, for BLC projects approved by CSMC in various meetings for creation of Capital Assets under Pradhan Mantri Awas Yojana - Urban (PMAY-U)- Housing for All (Urban) Mission (for beneficiaries under ST category) for the FY 2024-25 under SLS ML36 - PRADHAN MANTRI AWAS YOAJANA -HOUSING FOR ALL (PMAY).

- 2. The above central grant is being released subject to the following conditions:
 - Necessary sanctions/ approvals/ compliances required under the statutory or other i. regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
 - The State Government and Implementing agencies shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
 - The State Govt./implementing agencies shall generate payment files accordingly and utilize iii. the grant in accordance with the approved guidelines for the implementation of the Scheme of PMAY-U.
 - As the State has already on boarded on SNA Sparsh and requested for issue of Mother Sanction under PMAY-U, the Central assistance is being released on the basis of balance fund available in SNA Account of the State as per SNA 01 report as on 07.02.2025. The Central share available in the SNA account should mandatorily be returned in CFI immediately under intimation to this Ministry along with documentary proof for release of balance Central share under SNA Sparsh modal.
 - Any unspent balance lying in the State Treasury/SNA Accounts prior to on-boarding of the State Government on SNA SPARSH will be subject to guidelines issued by DoE from time to time.
 - The fund shall be utilized for the purpose and within the selected categorized beneficiaries, for which these are given. Otherwise, these will have to be refunded along with interest as per provisions under GFR-2017. Cont...2/

- vii. The State Government shall ensure the geo-tagging of all the houses approved under BLC component of PMAY-U for claiming balance part of due installments.
- viii. State Government shall ensure that the specifications of the houses conform to NBC/IS Standards and that requisite infrastructure will be provided by the State Government/ULB.
- ix. State Government should ensure that there is no violation of Model Code of Conduct while releasing funds to implementing Agencies/ULBs/Beneficiaries.
- 3. The amount is debitable from the account of the Central Government in the books under the following Head of Accounts under Demand No. 60 of M/o Housing and Urban Affairs for the year 2024-25.

As per rule 236(1) of GFR, 2017, the relevant accounts of the Grantee Institution(s)/Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
