Sub: Mother Sanction for release of ₹18,63,90,000/- to State Govt. of Assam as 1st installment of Central Assistance for 7 BLC projects approved by CSMC in its 5th meeting under PMAY-U 2.0 Mission for the Financial Year 2025-26 - reg.

Sir,

I am directed to issue the Mother Sanction, with the approval of competent authority, to release **₹18,63,90,000/- (Rupees Eighteen Crore Sixty-Three Lakh and Ninety Thousand only)** to the State Govt. of Assam as 1st installment of Central assistance for 7 BLC projects approved by CSMC in its 5th meeting for creation of Capital Assets under Pradhan Mantri Awas Yojana – Urban (PMAY-U)- Housing for All (Urban) Mission for the FY 2025-26 under SLS AS345 - Pradhan Mantri Awas Yojana 2.0 - BLC through SNA SPARSH. Details of the projects/release are as under:

2. Based on the scheme guidelines, decisions & recommendations of CSMC under PMAY-U 2.0 and compliances achieved by State Govt. in respect of aforesaid projects, the amount of central grant is being released subject to the following conditions:

- i. Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- ii. The State Government and Implementing agencies shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- iii. The State Govt./implementing agencies shall utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of PMAY-U 2.0.

- iv. Any unspent balance lying in the State Treasury, SNA Accounts prior to on-boarding of the State Government of SNA-SPARSH will required to be transferred immediately to Consolidated Fund of India (CFI)/ Consolidated Fund of State (CFS) as the case may be as per the guidelines issued by DoE for SNA SPARSH.
- v. The State Government shall ensure the geo-tagging of all the houses approved under BLC component of PMAY-U 2.0 at different levels for release of subsequent installment of Central assistance.
- vi. State Government shall ensure that the specifications of the houses conform to NBC/IS Standards and that requisite infrastructure will be provided by the State Government/ULB.
- vii. The 2nd installment of Central assistance under BLC will be released after State will submit the Utilization Certificate of atleast 75% of fund released by Centre as well as State Government in a Financial Year and commensurate physical progress.
- viii. The 2nd installment of 40% for BLC houses shall be released to "Lintel Stage" geo tagged houses from time to time.
- ix. State Government shall ensure that all houses under BLC vertical should be completed within 12-18 months from the date of sanction by the CSMC.
- x. State Government shall provide all basic civic amenities in the areas where BLC houses being constructed before completion of houses.
- xi. State Government shall ensure using the Unified Web Portal (UWP) of PMAY-U 2.0 for all related activities of scheme such as applications by beneficiaries, verification of beneficiaries, Geo-tagging of beneficiaries, attachment of beneficiaries, preparation/creation of projects, generating beneficiaries list, generation of releases of various installments of Central assistance and its utilization amongst others as per the prescribed guidelines issued by this Ministry, rather than creating/developing their own MIS system.
- xii. State Government should ensure that there is no violation of Model Code of Conduct while releasing funds to implementing Agencies/ULBs/Beneficiaries.

3. The amount is debitible from the account of the Central Government in the books under the respective Head of Accounts under Demand No. 60 of M/o Housing and Urban Affairs for the year 2025-26.

4. This admissible Central liability will be released to the Government of Assam on demand through SNA SPARSH only or/and as per the latest guidelines of Department of Expenditure. As the state has onboarded on SNA SPARSH, all the committed liabilities shall be released in SNA SPARSH only. The State Government is required to contribute approved matching state share under the scheme. State to ensure timely release of State matching share.

5. As per rule 236(1) of GFR, 2017, the relevant accounts of the Grantee Institution(s)/Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.

6. This sanction issues with the concurrence of the Finance Division vide **Note #19** of even No. File **dated 12.01.2026**.

This proposal is regarding release of ₹1863.90 lakh as 1st installment of Central assistance for 7 BLC projects approved in the State of Assam in the 5th meeting of CSMC held under PMAY-U 2.0.

The 5 2.th meeting of CSMC under PMAY-U 2.0 was held on 15th October, 2025 in which 2,071 houses in 7 BLC projects were sanctioned in the State of Assam. Details of projects approved, total Central assistance approved and release of 1st installment of Central Assistance recommended by the CSMC (pg.39-41/c) is enumerated hereunder:

As per the scheme guidelines of PMAY-U 2.0, Central Assistance under BLC vertical will be released to the States/UTs after the approval of CSMC and with concurrence of the Integrated Finance Division (IFD) of the Ministry. Total Central assistance of ₹2.25 lakh per dwelling unit (DU) will be released to North-East and hilly States, including the State of Assam. Central Assistance under the BLC vertical will be released in 3 installments of 40%, 40% and 20%. The status of Aadhaar seeded beneficiaries entries in UWP for these projects as on 11.11.2025 and 1 3.st installment of CA to be released is as follows:



The proposal from HFA Division seeks concurrence of IFD for release of **₹1863.90 lakh** to the State govt. of Assam as 1st instalment of Central Assistance (CA) for **2,071 houses in 7 BLC projects** approved by CSMC in its 5th meeting **under PMAY-U 2.0 Mission**.

PD has stated that in the 5th CSMC meeting held on 15.10.2025 under PMAY-U 2.0, **2,071 houses in 7 BLC projects** have been approved by CSMC for State of Assam {Minutes of CSMC meeting (pg.39-41/c)}.

PD has further stated that as per 3. scheme guidelines of PMAY-U 2.0, the funding pattern of 90:10 (Central : State) is **applicable** for the State of Assam and CA under BLC vertical is to be released in three instalments **in the ratio 40:40:20 (mentioned in para-9.3 of the scheme guidelines)**. As of 11.11.2025, Aadhaar validation has been completed for **2,071 approved beneficiaries in 7 BLC projects**. As per para-8.1 of the scheme guidelines, beneficiaries of the State of Assam are given Central Assistance **@₹2.25 lakh**, 40% (1st instalment) of which works out to **₹0.90 lakh**. Thus, 1st instalment of CA for the **2071 beneficiaries** works out to **₹1863.90 lakh** as detailed in table of para-3 of Note#9 (MIS details given at pg.156/c).

PD has further stated that 4. as per approved State/UT-wise revised tentative annual plan for FY 2025-26, an amount of **₹500 Crore** has been earmarked to the State govt. of Assam. As per state wise distribution of Expenditure 2025-26 under PMAY-U, total **mother sanction of ₹271.05 Crore** has been issued to the State govt. of Assam under PMAY-U and PMAY-U 2.0 in current FY 2025-26 so far.

PD has mentioned that 5. the State has onboarded on SNA SPARSH and the fund will be released to the State through **SNA SPARSH Module**. Sufficient fund is available in FY 2025-26 to issue **Mother Sanction** to the State of Assam. Category-wise details of above proposed release are given at para-4 of Note#9.

Accordingly, PD has sought the concurrence of IFD for release of **₹1863.90 lakh** to the State of Assam as 1st instalment of Central Assistance for **2,071 houses in 7 BLC projects** under PMAY-U 2.0 through SNA SPARSH Module after re-appropriation from the Non-functional head of NE States into relevant Functional Head of NE States for FY 2025-26.

The proposal has been recommended by **6.2JS(KN)** vide Note#13.

7. The instant proposal has been examined in IFD and it is noted that as per the SNA-01 dated 06.01.2026, there is **Nil** amount in the State's SNA account.

In view of the above and the recommendation of **8.JS(KN)** vide Note#13, IFD may concur (FC) in the PD's proposal for release of **₹1863.90 lakh** to the State of Assam as 1st instalment of Central Assistance for **2,071 houses in 7 BLC projects** (MIS details given at pg.156/c) approved by CSMC in its 5th meeting **under PMAY-U 2.0 Mission**,

subject to:

Approval of the competent authority, (i)

(ii) in view of para-5 above, issue of the sufficient Mother Sanction by the PD as per SNA SPARSH Model, but upto a maximum of 50% of the annual allocation for the State in one go, and

(iii) the release of fund is made through SNA SPARSH platform of PFMS within the budgetary ceiling in RE-2025-26 for PMAY-U & PMAY-U 2.0 and the tentative allocation earmarked for the State of Assam in CFY.
