- 2. Earlier, fund of Rs. 8.25 lakh was released to State Govt. of Tripura as 1<sup>st</sup> and 2<sup>nd</sup> & final instalment of Central Assistance for FY 2018-19 and 1<sup>st</sup> instalment of Central Assistance for FY 2021-22 for conducting Social Audit under Capacity Building activities of PMAY-U Mission vide sanction letter of even number dated 27.01.2023. The State Govt. has submitted the entire Utilization Certificate (UC) against the said release, which is **enclosed** herewith.
- 3. State Govt. of Tripura has submitted the documents mandated for release of 2<sup>nd</sup> & final installment of Central Assistance for FY 2021-22 and 1<sup>st</sup> installment of Central Assistance for FYs 2022-23, 2023-24 & 2024-25 for conducting Social Audit under Capacity Building activities of PMAY-U Mission.

- 4. The above grant is subject to the following conditions:
  - i. The State will conduct Social Audit as per the Capacity Building Guidelines issued by the Ministry.
- ii. 5-10% of the approved projects are to be selected for Social Audit with minimum size of at least 100 DUs grounded with beneficiaries identified.
- iii. Remaining 50% of Central Assistance would be released subject to submission of City-wise list of Social Audit Committee members, copy of sample tools used for Social Audit & State Level Social Audit report, duly signed by the State Mission Director/competent authority.
- iv. Further, remaining 50% of Central Assistance would be released as per actual and on receipt of Utilization Certificate along with Undertaking (in prescribed format mentioned in Capacity Building Activities Norms, Fund Disbursal Processes and Plan Templates) from the State.
- v. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- vi. The State will utilize the sanctioned grant for the purpose for which it is released, and furnish the Utilization Certificate (UC) as per GFR 2017.
- vii. The State Govts./Nodal Agency shall strictly monitor the progress of the preparatory work.
- viii. The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-U Mission.
- ix. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.
- x. Any unspent balance lying in State Treasury/SNA Accounts prior to onboarding of the State Government on SNA SPARSH will be subject to guidelines issued by Department of Expenditure (DoE) from time to time.
- 5. The expenditure involved is debitable to the following Head of Account under Demand No. 60 of Ministry of Housing and Urban Affairs for the year 2025-26 after duly re appropriation from the respective Non-functional Head to the Functional Head for NE States:
