**Sub.: Mother sanction for release of ₹41,29,20,000/- to State Govt. of Chhattisgarh as part of 2<sup>nd</sup> installment of Central Assistance for 6,882 houses Geo-tagged at Lintel stage and above in 396 BLC projects approved by CSMC in its 2<sup>nd</sup>, 3<sup>rd</sup>, 5<sup>th</sup> and 6<sup>th</sup> meetings under PMAY-U 2.0 Mission for FY 2026-27 - reg.**

Sir,

I am directed to convey the mother sanction of the competent authority to release ₹41,29,20,000/- (Rupees Forty One Crore-Twenty Nine Lakh and Twenty Thousand only) to State Govt. of Chhattisgarh as part of 2<sup>nd</sup> installment of Central Assistance for 6,882 houses Geo-tagged at Lintel stage and above in 396 BLC projects approved by Central Sanctioning and Monitoring Committee (CSMC) in its 2<sup>nd</sup>, 3<sup>rd</sup>, 5<sup>th</sup> and 6<sup>th</sup> meetings for Creation of Capital Assets under Pradhan Mantri Awas Yojana – Urban 2.0 (PMAY-U 2.0) Mission for FY 2026-27 under **SLS CT390 - BLC (BENEFICIARY LED CONSTRUCTION) - PMAY-U 2.0** through SNA SPARSH. Details of the projects/release are **annexed** herewith and are also as under:

2. The State Govt. has furnished requisite Utilization Certificates (UCs) (copy enclosed), physical progress of the projects and other necessary compliances as per scheme guidelines for release of 2nd installment of Central Assistance.

3. Based on the scheme guidelines, decisions and recommendations of CSMC under PMAY-U 2.0 and compliances achieved by State Govt. in respect of aforesaid projects, the amount of central grant is being released subject to the following conditions:

1. Necessary sanctions/approvals/compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project(s).

- II. The State Govt. and Implementing Agencies shall put in place a monitoring system to ensure that the project(s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- III. The State Govt./Implementing Agencies shall utilize the grant in accordance with the approved guidelines for the implementation of the scheme of PMAY-U 2.0.
- IV. The fund shall be utilized for the purpose and within the selected categorized beneficiaries, for which these are given.
- V. The State Govt. shall ensure the geo-tagging of all the houses approved under BLC component of PMAY-U 2.0 at different levels for release of subsequent installment of Central Assistance.
- VI. The State Govt. shall ensure that the specifications of the houses conform to NBC/IS Standards and that requisite infrastructure will be provided by the State Govt./ULB.
- VII. The balance amount of 2nd installment of BLC houses shall be released to "Lintel Stage" geo-tagged beneficiaries from time to time and after submission of the Utilization Certificate of atleast 75% of fund released by Centre as well as State Govt. in a Financial Year.
- VIII. The State Govt. shall submit Action Taken Reports (ATRs) on Third Party Quality Monitoring (TPQM) report after release of 50% Central Assistance in a particular BLC projects.
- IX. The State Govt. shall ensure that all houses under BLC vertical should be completed within 12-18 months from the date of approval by the CSMC.
- X. The State Govt. shall provide all basic civic amenities in the areas where BLC houses being constructed before completion of houses.
- XI. The State Govt. shall ensure using the Unified Web Portal (UWP) of PMAY-U 2.0 for all related activities of scheme such as applications by beneficiaries, verification of beneficiaries, geo-tagging of beneficiaries, attachment of beneficiaries, preparation of DPRs, generating beneficiaries list, generation of releases of various installments of Central Assistance and its utilization amongst others as per the prescribed guidelines issued by this Ministry, rather than creating/developing their own MIS system.
- XII. The State Govt. should ensure that there is no violation of Model Code of Conduct while releasing funds to Implementing Agencies/ULBs/Beneficiaries.

4. The amount is debitible from the account of the Central Government in the books under the respective Head of Accounts under Demand No. 60 of Ministry of Housing and Urban Affairs for the year 2026-27.

5. This admissible Central liability will be released to the Govt. of Chhattisgarh on demand through SNA SPARSH only or/and as per the latest guidelines of DoE. As the State Govt. has onboarded SNA SPARSH, all the committed liabilities shall be released in SNA SPARSH only. The State Govt. is required to contribute approved State Govt. matching share under the scheme. The State Govt. to ensure timely release of State Govt. matching share.

6. As per rule 236(1) of GFR, 2017, the relevant accounts of the Grantee Institution(s)/Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.

7. This issues with the concurrence of the Integrated Finance Division vide their **Note # 80** of even number dated **25.06.2026**.

8. The sanction has been registered at **S.No. 169** in the Sanction Register of HFA Directorate (HFA-III Section) of the Ministry of Housing and Urban Affair for the year 2026-27.




